I would also like to thank Kevin and Craig for working on our timed program. This is the first season we have done this and no doubt we will have all learned from this and can improve next season.

We hosted the Region 4 Championships at Myimbarr Community Park this season and there was a lot of negativity leading up to these championship but I must acknowledge the work Kevin and the committee from Lake Illawarra did to ensure all the relevant issues were addressed and the ground was in excellent condition for the championships. To everyone that came and helped with the setup on the Friday I thank you. It was not an easy task but for every part you played thank you. I would like to thank Craig Scott for his valued contribution to helping me with all the administrative tasks, like getting the program ready. Your assistance is greatly appreciated once again. Thanks also to everyone that assisted over the weekend whether it be big or small championships don't run without your assistance.

To everyone around the "table" thank you for your time and effort you all put in for not only this zone but your own individual centres. Without the dedication of all of us around the table centres may not function well. Can I ask that you take back to your committees, either old or new a BIG thank you from myself for all their hard work and dedication they have put in during a somewhat different season than in the past. I know from experience that this can be a thankless task, but myself and all the athletes within this zone very much appreciate your dedication and appreciate your help as without it athletes wouldn't be able to participate in such a wonderful sport as athletics.

I ask you all to congratulate your respective athletes that made it to State Championships which, under the present circumstances, did not take place this season.

In closing I'd like to congratulate all athletes within the zone on the sportsmanship and respect they all showed towards our zone officials.

Treasurer's Report

The 2019/20 year for MSCZ was overall financially sound year with the Zone finishing the year off with a profit of \$2,339.92.

Our term deposit earnt \$401.42 interest in the 12 months from Feb 2019 to Feb 2021. This interest has been reinvested into the term deposit which now has a balance of \$17,127.34 with a maturity date of 2nd February 2021. Unfortunately the interest rate has dropped from 2.4% to 1.45% which is better than the current IMB offered rate of 1.25% which is what the rated dropped to earlier this month.

Our everyday transaction account has a closing balance of \$5,257.37 with no current receipts or payments outstanding.

To break down the year;

Our overall net profit as previously advised was \$2,339.92 dissecting this we can break this down into;

- \$1,471.73 profit for the regular year excluding Regionals which is \$1,305.82 up on the previous years profit which is a combination of increased membership and sponsorship along with greatly reduced overall zone carnival expenses. Thank you to BlueScope for their continued sponsorship of our zone.
- Our regional carnival despite some nervous moments provided us with a net profit of \$868.19. The best performing area of the regionals was our BBQ making us the most overall % in profit so a huge thanks to Albion Park for keeping costs down.
