6.3Delegate Reports

<u>Kiama</u>

It's pleasing to see that our increase in numbers this season has resulted in larger numbers of athletes competing in the Grand Prix Carnivals. Zone entries are also up this year even though we lost our last evening of competition prior to Christmas due to rain.

Work on our new Long Jump facility is continuing. Concreting is complete and the synthetic surfacing of the run-ups is scheduled for late January.

Our local newspaper, The Kiama Independent, has been very supportive of the Centre this season. We have been fortunate to have articles and photos published in nearly every edition. This exposure has certainly raised the profile of Little Athletics in the local community and is no doubt responsible for some of our new registrations. We've have also submitted several stories to LAANSW Run For Fun E-News and were pleasantly surprised when one article was given front page in the last publication.

Competition resumes on Friday 12th January after the Christmas/New Year break and we look forward to the challenge of the Zone Championships.

Albion Park

Entered State Relays in mixed events.

1 athlete in the Trans Tasman team and 72 entered in Zone Championships. Carnival was successful and a special thanks to Craig Scott for his help. Club resumed last week and all it going well.

Shoalhaven

Currently we have 3092 athletes. Started the season late due to unavailability of the ground (lost 5 weeks) and lost 1 night due to rain. Grand Prix and Zone entries are sadly down due to various

reasons (3 large families have left). Many other athletes simply want to participate on Tuesdays and late start to season has hampered interest/communication.

Under 12 girls competed at State relays gaining a silver in high/long jump.

Two season projects, BBQ shelter and the surfacing of the long jump run ups have been completed.

Season continues tomorrow night - the 9th.

7. General Business

7.1 Zone Report

Ground inspection completed and the oval is in good condition. There were two concerns raised over safety. Firstly, Lake Illawarra have had new long/triple jump run ups installed and they are extremely hard. It will be recommended that athletes do not use spikes as they will not penetrate the surface and in turn make the run up slippery. Craig Scott also raised concerns over receiving complaints from athletes and parents over impact injuries to athletes of their ankles, knees and hips and also the likelihood that it's very possible that an athlete could fall and injure themselves on the hard surface. Chiefs at this event will advise the athletes of the surface and recommendations.

It was decided to use the north south discus areas at Lake Illawarra as the circles which face west bring both the finish line and cricket pitch into play for big throwers. Paul Joines to locate additional chief so that events are not held up when referee duties being completed.

Track Marshalling will be in the north west corner of the ova. The equipment shed will be used as the computer room.

No Parking available within the grounds. Delegates are to tell their members that tents etc can be offloaded but all cars must out by 7:30am.

No security being provided on either Friday or Saturday nights.

Discussed the possibility of running the 3km on the Friday night. Pros & cons discussed being determined that it's a good idea but Centres doing their own programs on the Friday night and cost wise for travellers for 1 event not practical. Decided against on this occasion but the thought of a twilight meet in the future could be considered.

Kiama & Shoalhaven to provide walkie talkies. Lake Illawarra to organise batteries. Receipt for same to be provided for reimbursement. Receipts for purchases to supply lunches for officials, up to the value of \$300, to also be provided. Starting caps to also be purchased by Lake Illawarra with the Zone to reimburse.

Col Anderson to provide a financial report of the carnival and give to Peter by the Regional Championships. Peter to forward this to the Association.

Peter & Craig went through the program with Howard explaining the pages which he needs to replace with his own information and also the pages which need to stay as they are.
